Section 6.1 shall be amended to read as follows:

A Lot may be rented by its owner provided however, that all leases or rental agreements pertaining to a Lot shall Specifically subject the lessee to the requirements of this Declaration, and all rules and regulations of which shall have been properly adopted for the operation of this development. Use of the property for other than residential purposes is expressly prohibited.
